#### 1 Acceptance of the Terms of Use

The present Terms of Use govern the use of the 'Health Coach' service provided by CSS Kranken-Versicherung AG (hereinafter referred to as CSS). By contacting the CSS Health Coaches by telephone, in writing, electronically (e.g. by email, css.ch or the active365 app) or in person, the Client confirms that they agree to be bound by these Terms of Use. These Terms of Use can be accessed and consulted at any time at css.ch/health-coach. When contact is made via the active365 app, the terms and conditions of use of the active365 app – which the client must agree to in advance and which can be accessed and viewed here – also simultaneously apply.

These Terms of Use are written in gender-neutral lanquage.

#### 2 Legal entity and eligibility

- 2.1 As CSS employees, CSS Health Coaches answer personal questions on health and insurance cover. This service is provided by CSS (CSS Kranken-Versicherung AG, headquartered in Lucerne at Tribschenstrasse 21, 6005 Lucerne). Insurance cover must be held with CSS in order to use this service.
- 2.2 Contacting a Health Coach does not in itself entitle a Client to use a service. CSS Health Coaches may decide to refuse services. They are not required to give reasons.

#### 3 Services provided by CSS Health Coaches

#### 3.1 Service content

- a) Referral to offers and other sources of information CSS Health Coaches answer questions on health and insurance cover. Drawing on available, scientifically founded and valid sources, they provide information on offers or points of contact at CSS or other providers, specifically patient organisations and associations. CSS Health Coaches issue generally valid information without assessing the personal health of the Client. This is no substitute for a personal consultation, examination or diagnosis by a recognised doctor. Depending on the situation, the information provided may be a useful addition to the dialogue between doctor and patient.
- b) Coaching and counselling as additional services
  CSS Health Coaches offer more extensive coaching in
  the form of additional services relating to exercise, diet,
  resilience, sleep, and other mental health issues (see
  also section 4.2 below). CSS Health Coaches support
  and encourage Clients with counselling on further
  health-related issues. Coaching and counselling may be
  offered by CSS as fee-based services. The actual costs
  are notified in advance by suitable means. At the discretion of CSS, the level of such costs may be set according to the insurance products (KVG or VVG) that the
  Client has taken out with CSS or CSS Versicherung AG.

#### 3.2 No medical advice/consultation

CSS Health Coaches do not offer any medical services, neither do they conduct any diagnostic and/or treatment procedures. The following medical services and diagnostic and treatment procedures are explicitly not provided by CSS Health Coaches: evaluation and assessment of symptoms in an individual case, assessment of the diagnosis or severity of a condition in an individual case, or intervention in treatment (e.g. by determining the next stages of treatment, proposing changes to the drug regimen, or recommending that a particular treatment be continued). In these or similar cases, CSS Health Coaches may refer to the doctor or therapist responsible. In the case of acute health problems, subject to the provisions of their insurance model, Clients should contact their doctor directly. Should it emerge in discussions with one

of our Health Coaches that the Client has an urgent medical issue, should they wish the CSS Health Coaches will forward the call to our 24-hour medical advice service on 058 277 77 77.

#### 3.3 No commitment to provide cover

The CSS Health Coach does not issue any commitments to provide cover as part of their work (with the exception of the health programmes and the second opinion). It requires separate investigation by the CSS insurance business. In this case, please contact our Client Services Centre on 0844 277 277.

#### 4 Costs

#### 4.1 Contact request and initial consultation

Contacting the Health Coach and the initial coaching session are free of charge. Contacting a Health Coach does not in itself entitle a Client to a free initial coaching session. CSS Health Coaches may decide to refuse services. They are not required to give reasons.

After the free initial consultation, Clients are offered the option of further follow-up sessions (also referred to as the 'additional service').

#### 4.2 Follow-up coaching (fee-based additional service)

- a) Following the free initial consultation, CSS Health Coaches offer fee-based follow-up coaching (additional services). These are consultations or coaching sessions focusing in particular on the diet, exercise, resilience and sleep aspects of health, as well as other mental health issues. This list is not exhaustive. Please refer to the valid, updated range of offers that can be accessed at css.ch/health-coach. CSS may extend, restrict, suspend or cancel the additional services at any time at its discretion.
- b) The contract for follow-up coaching is established by mutual consent. CSS or the CSS Health Coach service may refuse to enter into a contract for fee-based follow-up coaching without stating its reasons for doing so. Once the contract has been concluded, Clients are not entitled to claim follow-up coaching until they have paid the agreed fee.
- c) The costs of follow-up coaching are based on the quote drawn up by the Health Coach. If a contract for follow-up coaching has been concluded, the agreed terms of that contract also apply.

#### 5 Payment

The invoice for a fee-based additional service must be paid within 30 days.

#### 6 Appointments

- 6.1 Clients make an appointment for a coaching session by phone, by email, online via the appointment booking tool or the active 365 app.
- 6.2 If an appointment that has been agreed and confirmed cannot be kept, the Client must notify the Health Coach no later than 24-hours prior to the start of the appointment. If the Client cancels the appointment later than this 24-hour cutoff, they may be charged the costs of the coaching session. In the event of a dispute, it falls to the Client to prove that they cancelled the appointment in good time.
- 6.3 If it is impossible to conduct or proceed with the appointment for technical reasons or as a result of force majeure for which neither contracting party is obviously responsible, the coaching session is deemed to have not been held. The Client cannot be charged any costs in such cases. The Client is entitled to have the coaching session that was interrupted or not held conducted at a later date. The parties will agree a new appointment.

#### 7 Term, form and termination

- 7.1 The term of the contract is based on the quote submitted by the CSS Health Coach. CSS Health Coaches determine the time period in which the coaching sessions should ideally be held.
- 7.2 The sessions are usually held by telephone or video link. Clients agree with the CSS Health Coaches on the form in which their sessions will be held.

#### 7.3 Termination by a Client

A Client may withdraw from and terminate the contract only in justified cases and for good cause. Good cause might be, for example, if a service from the CSS Health Coach can no longer be used for objective reasons, or if its use objectively clearly appears to be unreasonable. The Client must declare their withdrawal from the contract in writing, stating reasons. In the event of withdrawal for one of the reasons mentioned, the Client forfeits their right to the coaching sessions that have not yet been held. The costs paid for these coaching sessions will be reimbursed to the Client.

#### 7.4 Termination by a CSS Health Coach

- a) Health Coaches also have the right to withdraw from and terminate the contract on the aforementioned grounds (see section 7.3). The costs paid for the coaching sessions that will no longer be held will be reimbursed to the Client. There is no entitlement to the coaching sessions that have not yet been held.
- b) The Health Coach may end the contractual relationship unilaterally on other grounds, specifically if they regard continuing the relationship as inadvisable from a professional or personal perspective. The contractual relationship may also be dissolved unilaterally if the Client's behaviour is inappropriate or abusive.

#### 8 Changes to the service by CSS

CSS reserves the right to amend the services, terms of use and offer conditions at any time without prior notice.

#### 9 Exclusion of liability

#### 9.1 General

CSS and the Health Coaches it employs explicitly accept no liability whatsoever for any and all damage or loss. Health Coaches have many years of professional experience and provide information to Clients with the greatest possible care, taking into account the latest findings from scientific research and development. Neither CSS nor the Health Coaches offer any form of assurance, guarantee or warranty of any kind in connection with the coaching services, in particular that information, recommendations, suggestions or motivation will lead to a specific outcome.

#### 9.2 In the event of loss as a result of third-party services

Should a Client use a service from a third party that was recommended to them by CSS Health Coaches, in the event of loss or damage the provisions of the contract between the Client and the third party, or the latter's general terms and conditions, apply. CSS accepts no liability whatsoever for damage or loss resulting from the use of services provided by recommended third parties.

#### 10 Data protection

10.1 CSS processes your data to identify you as a person insured with CSS, to check whether you have the insurance cover required to take advantage of the Health Coach offer and to ensure the quality of the service provided by the Health Coach and continue developing the offer. To do this, it uses data that it already holds about you, such as your first and last names, gender, date of birth, insurance number, language, address, phone number, email address, communication channel and insurance cover.

If use is made of the 1:1 Video Coach in the active 365 app, the following data is processed and shared with CSS Kranken-Versicherung AG:  $\frac{1}{2}$ 

- Email address for contact with the CSS Health Coach (e.g. appointments, satisfaction survey)
- The user's first and last name (optional information) to enable the Coach to address them personally
- Coaching topic (optional information) to help assign the Coach and determine the focus of the video conferencing coaching sessions
- Phone number
- Language

If the user enters their email address or the optional information mentioned above when using the 1:1 Video Coach, CSS Kranken-Versicherung AG will become aware of the fact that the user is using the app. The user consents to this.

# 10.2 Relationship between CSS Health Coaches and the insurance business

The CSS Health Coaches may create notes of the conversation. These can only be accessed by employees of the CSS Health Coach section.

Employees of the insurance business have no access to the data stored by the CSS Health Coaches or to the content of telephone and video calls. The exception here is the information that a call took place, and when. This is to ensure continuity in client care.

The CSS Health Coaches have access to insurance business data, but not to medical data. If a CSS Health Coach needs to be aware of a Client's medical history (e.g. their medication, treatments completed or pre-existing conditions), the Client is required to provide this information at the coaching session. If they do not, this history cannot be considered.

#### 11 Feedback

Having used our services, Clients will be contacted to give their feedback on the CSS Health Coach. Participation is voluntary. The data collected in this way is used to continue developing the offer and to ensure its quality.

#### 12 Final provisions

#### 12.1 Severability clause

Should one of the present Terms of Use be or become invalid or ineffective, the validity of the remaining Terms of Use will remain unaffected. The invalid or ineffective provision must be replaced by a provision that reflects the financial objective of the ineffective provision as closely as possible.

#### 12.2 Applicable law and place of jurisdiction

Swiss law applies in the event of any legal dispute. The sole place of jurisdiction is at the head office of CSS Kranken-Versicherung AG.

#### 12.3 Amendment of the Terms of Use

The present Terms of Use were adopted by CSS on 5 October 2022 and entered into force on the same date. CSS is entitled to amend the Terms of Use at any time without prior notice. The Terms of Use can be accessed in their currently valid form at css.ch/health-coach. The most recent version applies in each case.
